THE EIGHT TABLES THAT FOLLOW provide the names, districts and states represented, seniority, DC office locations, and phone numbers of 77 House and Senate appropriation subcommittee members, along with the appropriations subcommittees on which they serve. These are the appropriations subcommittee members who oversee the annual appropriations for the Departments of Agriculture, Energy, Interior, and Transportation, and Environmental Protection Agency.

These tables are being provided to assist you in your outreach to support of AFCC's requests to (1) create a development capital grant program in the Department of Energy's Loan Programs Office and (2) increase opportunities for funding innovations and game-changing innovations through unsolicited proposals directed to the Departments of Agriculture, Energy, Interior, and Transportation, and Environmental Protection Agency.

The tables list 45 House Members and 32 Senators representing 26 states to which AFCC has sent its appropriations requests.
